October 4 Poulsbo Artist League Annual Business Meeting Minutes


The meeting was called to order at 1:00 pm by Vice President Kay Boyce. President Garven Kinley was absent due to illness. Nineteen members were present.

Now in its 17th year, the CVG Show is an annual all-media open-themed juried art competition for Washington State artists with over \$10,000 in cash and awards.

It will be held in the Collective Visions Gallery in Bremerton, Washington, from January 13 through February 23, 2024. There are three separate categories for entry: Two-Dimensional, Three-Dimensional, and Photo/Digital art, with prizes in each category.

The entry fee is \$45 for 2 artworks; the entry deadline is November 19, 2023. All work submitted must have been completed on or AFTER Jan 1, 2021
